DRINK NEAR THE SYSTEM, IF FOOD OR DRINKS ARE SPILLED  
ON THE SYSTEM IT MAY CAUSE DAMAGE AND REMEMBER IF  
YOU BREAK IT YOU BUY IT, THE REPLACEMENT COST IS  
AROUND \$4000.00, NO ALCOHOL TO BE CONSUMED BY USER  
OR ANYONE HELPING WITH THE SYSTEM.**

**EACH CHILD MUST HAVE A PARENTAL/GUARDIAN CONSENT FORM FILLED OUT AND SIGNED.(THIS FORM IS TO BE RETURNED WITH THE SYSTEM)**

**A CHILD INFORMATION FORM MAY BE FILLED OUT TO HELP YOU WITH DATA ENTRY, HOWEVER THIS FORM MUST BE RETURNED TO THE PARENT/GUARDIAN WITH THE CD AND ID PACKET.**

**THE COMPUTER DOES NOT RECORD ANY INFORMATION, NOTHING IS STORED IN A DATA BASE.**

**THE LODGE HOLDING THE EVENT MUST SUPPLY THE CDR TO BE USED AND GIVEN TO PARENT OR GUARDIAN WITH ID INFO ON IT. YOU CAN NOT CHARGE FOR THIS SERVICE IT IS A FREE COMMUNITY SERVICE. ALSO GET CD ENVELOPES TO PROTECT THE CD. YOU MAY ALSO BURN THE INFORMATION ON A FLASH DRIVE IF THE PARENT OR GUARDIAN HAS ONE.**

**FINGERPRINTING IS RECOMMENDED ON CHILDREN 6 MONTHS OR OLDER, YOU CAN ALWAYS TAKE PHOTOS AND INFORMATION AND PUT IT ON THE CD IF THE CHILD IS TOO YOUNG, OR UNCOOPERATIVE WITH FINGERPRINTING. PLEASE DO NOT FORCE A CHILD OR ADULT TO GET FINGERPRINTED WE DO NOT WANT THIS TO BE A TRAMATIC EXPERIENCE.**

**EACH ID PACKET SHOULD HAVE THE CD, A HEARD OF MOOSE HANDOUT, AND A SAFE SURFIN HANDOUT. ON THE CD WILL BE THE CHILD IFORMATION, PUZZLES, GAMES, AND INFORMATION FOR PARENTS FOR CHILD SAFETY AND HOW TO MAKE A HOME DNA KIT.**

**USE THIS TOOL TO PROTECT A CHILD INTRODUCE THEM TO THE MOOSE INFORM THEM ABOUT SAFE SURFIN.**

**THE SYSTEM MUST BE RETURNED WITHIN 48 HOURS OF THE EVENT.**

**THIS AGREEMENT MUST BE SIGNED AND DATED BY THE LODGE GOVERNOR AND ADMINISTRATOR AND READ TO THE BOARD OF OFFICERS.**
