

# From the Desk of MD-DE-DC Regional Manager Jim Hale



Message from the Regional Manager -

Another Moose year is just about to go into the history books and I hope your lodge is one of those that have shown great progress this year. If not, it's because enough effort was not put into it by <u>all</u> the officers. Where are you standing on membership? Membership Retention? Financially? Is your Lodge on target to receive the Premier Lodge Award?

In all my years of Moose membership, I don't think I have ever seen a year that has been so full of membership incentives as this past year. Everything from incentives to join, a chance to win trips, a chance to win a car, zero application fees, free dues and now the

chance to receive a free Life Membership. There is no excuse why every Lodge in this fraternity is not showing greater growth and greater prosperity this year. So why do some Lodges flourish and some Lodges fail? Maybe it is time to look at the officers you elect to be the keepers of your lodge. Each elected office comes with specific duties and if your elected officers are not fulfilling these jobs, maybe, just maybe, you voted for the wrong individuals.

All too often we see individuals run for office because they think it will help them in achieving a higher degree instead of by demonstrating leadership. Or they do so thinking they will get their way paid to conventions? These are not the right reasons for running for office. *NOW IS THE TIME* to make changes. But do your prospective officers really understand what that involves? Let's take a brief look at the goals and duties of the officers:

**The Governor:** 1) Should be knowledgeable about our organization, its practices, of people's strengths and talents; and about the changing world around our organization. 2) Should have a vision and see how things can be better. 3) Be motivated and inspired and determined to move forward and the ability to communicate with people.

**The Junior Governor:** The duties of the Junior Governor is: 1) The Vice President of the corporation. 2) Attend Lodge, Board of Officers, and House Committee meetings 3) Assist in preserving order and decorum in meetings 4) Serve on the Mooseheart/Moosehaven Admissions committee. 5) Serve on the Rookie of the Year Committee 6) Assist the Governor in counting votes.

**The Prelate:** The duties of the Prelate include: 1) Attend Lodge, Board of Officers meetings and House Committee meetings 2) Preside in the absence of the Governor and Jr. Governor. 3) Serve on the Rookie of the Year Committee 4) Remain alert to the responsibilities of the Governor and Jr. Governor 5) Serve on Auditing Committee 6) Visit the sick, disabled and distressed and provide full report.

**The Junior Past Governor:** The duties of the Junior Past Governor include: 1) Attend Lodge, Board of Officers and House Committee meetings 2) Assist in completing projects begun in preceding year 3) Preside at meetings in the absence of the Governor, Junior Governor and Prelate 4) Serve on Mooseheart/Moosehaven Admission Committee 5) Serve as the Installing Officer 6) Serve on Rookie of the Year Committee 7) Serve as chairman of Moose of the Year committee.

**The Administrator:** The duties of the Administrator include: 1) Attend, record and maintain minutes of all meetings 2) Sign and file the minutes properly approved 3) Draw and sign all checks as necessary 4) Collect funds from all sources, including committees, and issue receipts for all funds received 5) Deposit all funds, but not less that weekly 6) Keep an accurate accounting of all income and expenditures on computers 7) Retain and file all original documents 8) Compile all required reports including membership and financial 9) Maintain all required records on membership 10) If selected, serve as representative to the Supreme Lodge and as a delegate to State Association meetings and conventions 11) Along with Governor and Treasurer, shall be responsible for the securities and valuable papers in a safe place. The Treasurer: The Treasurer is the Treasurer of the corporation and his duties include 1) attending Lodge, Board of Officers and House Committee meetings 2) Ensure Administrator makes deposits no less than weekly 3) Receive duplicate deposit slips, initial and retained by Administrator 4) Shall be the custodial of all securities along with Administrator and Governor 5) Perform other duties as required by the laws of the Order 6) Sign authorized checks 6) Conduct weekly inspection of financial records ensuring they are current and consistent with receipts and expenditures 8) Serve on Rookie of the Year committee 9) Perform duties of

Administrator whenever a vacancy occurs.

The duties of the three Trustees include: 1) Attend meetings 2) Take inventory of all furniture, fixtures, paraphernalia and other property at least annually 3) Take House Committee merchandise inventory monthly 4) Examine and approve all bills except recurring overhead bills weekly 6) Conduct quarterly inspection of physical properties, with special attention to the cleanliness, state of repair of Lodge Home, Social Quarters and furnishings and equipment.

Furthermore, the Administrator and Governor shall be the delegates to International, State Conventions, Mid Year Conferences and District Meetings. 

# TeamMoose Raises over \$6000 to Fight Childhood Cancers

A couple years ago, Don Vasold of Gardenville Moose Lodge#1242 joined a friend of his at a quirky event that had people paying to have their heads shaved! The event was called "St. Baldrick's Shave-a-Thon" and its purpose was to raise badly needed funds for research to fight juvenile cancers. Why shave their head? To show solidarity with children who loose their hair in the course of chemotherapy and radiation treatments.

The event was held at a local restaurant that year and hosted about 65 shavees. Participants were friends and families of

children battling this disease. Don described a mom telling about her toddler who had just passed away two months prior to this event and he soon found himself overcome with emotion. He left the room unable to imagine if he were in her shoes and has since, joined other shavees each March to have his head shaved. Last year at the March 2010 District Meeting, Don asked other Moose members from the Mighty 3rd District to join him in the cause. Only members of Gardenville Lodge volunteered to be shaved and raised over \$3200. This year, Don again tried to rally members of the Mighty 3rd District. Not many answered, 13 members (10 from Gardenville Lodge and 3 from Essex Lodge #70) raised funds and surrendered their locks to the razor! It may have only been a few brave brothers, from one pre-teen to septuagenarians answering Don's rallying cry, but they've raised over \$6,000 with more pledges to be counted and collected! Don expects the total to be well over \$7,200! These guys truly live the

The event organizers gave a total of 194 shavees, \$94,000 collected before the event with an unofficial total of \$120,000 with more expected. Shane, who had been listening quietly, piped up, "I know why."


Startled, we all turned to him. What came out of his mouth next stunned me. I'd never heard a more comforting explanation. It has changed the way I try and live...

# Government Relations Message by Association Coordinator Bessie Staab-Hickman

Going through the listings for Delaware General Assembly I find little or no legislation pending that would

have an impact on our lodges. The entire proposed budget will be aired soon that may change things. Maryland has several that would bear watching Senate Bill 4 First reading, Senate Bill 9, Senate Bill 128, Senate 249 House 39, Senate Bill 875. These range from getting special liquor license's in individual counties, video gaming, and slot machines for some non-profits. To find all legislation, go to State of Maryland General Assembly or Delaware General Assembly. In Maryland don't forget you have a bill pending that will increase the cost of alcoholic beverages if passed. That information was handed out at winter conference. Listings of all Senators and Representatives are now published on the web sites. The District of Columbia has Wards they are listed also. Each Lodge and Chapter should have National, State, County, City, Ward or whatever pertains to their area for reference and use. I was really encouraged when



several Lodge brothers came and asked for information, and I received the names of several chapter members who are currently serving as chairpersons. Perhaps this program will finally get the attention it deserves.

Has anyone noticed the leap in prices? It is not just at the pumps it's \$.50 on milk, eggs, meat, ice cream just to mention a few. Gas prices jumped when unrest in the Middle East was aired before there was ever one tanker to reach our shores. My question is why? The majority of our oil does not come from the Middle East and we only import 8% from Libya. Years back this was called gouging our president stated when asked why we did not tap into our reserves his answer was (or words to that effect) we have to worry about our allies and world economy. What about our economy? At the rate of some increases you won't be able to afford the gas to go to work (if you are fortunate to have employment). Again perhaps I'm overly suspicious BUT that just seemed to give the Oil industry a green light to keep raising prices and of course when that goes up so does everything else. Another e-mail is the Bakkan Oil Strike - why is that not being developed? I've sent my e-mails and made calls asking that question of our officials, don't have an answer yet, I'll share if and when there's a response.







By now all the Fraternity knows that the Association has taken on the MD-DE-DC House in lieu of our yearly project. We have all heard Jim Hale state that it takes \$180,000.00 a year to run our house and, if you were at the mid-year in Ocean City, you would know there is no doubt that it's our house.

I disagree with the Association on only raising 2/3rds of the funds needed. Instead of raising \$120,000.00 as our target, we need to raise the full amount. With approximately 24,000 members of the LOOM the amount per member comes to \$7.50. A Lodge with 160 members would need to raise \$3,750.00 and a Lodge of 1,300 would need to raise \$9,750.00. Notice the word RAISE. For Lodges who have slots where they must donate 50% to charity, the funds could come from this source. Other Lodges need to plan fund raisers.

Starting May 1st the officers have a responsibility to see that their Lodges are fiscally sound. This means most of our Lodges must raise money for the MD-DE-DC House and not take it from Lodge funds.

Can we raise all the money needed? We won't know until we try. Some Lodges can afford more than their share thus helping those Lodges that cannot.

Brothers, this is a heavy responsibility and we must give it our best try!



# In the Spotlight - Pilgrim Carl Salo



Carl Salo was a member of the Loyal Order of Moose for nearly 28 years having joined Middle-

Where does one start when one has done so much, for so long, for so many? Carl took an active interest in his Lodge and was asked to be the Membership Chairman in 1988. He has filled the years by the use of his hands and love in his heart for our Fraternity and its people. For the past 24 years, Carl has been dedicated in service to every unit of our Order starting with his home Lodge in Harrington. He spent a lot of time in the kitchen cooking for Wednesday Seafood Night, Friday Night Buffet, and preparing dinners for the Forresters, Senior Citizens and Fellowship functions on Saturday nights. He also volunteered his time at the Moose Stand at the Delaware State Fair every July.

Carl was not only busy in the kitchen - he also chaired or worked on a committee, including numerous Community Service projects. He participated on the Christmas Basket Committee for needy families for the past 14 years.

Or he could be found in the Ballroom practicing his Ritual part. An avid ritualist, Carl believed in the Moose story and enjoyed opportunities to relay the message. Knowing many of the parts, Carl was asked to fill in on many occasions. In 2003, when

he was serving as Orator with his team, he finished in first place in his part, as well as being the Top Ritualist in the Association.

In Carl's involvement at the Harrington Moose Family Center, he served as a maintenance mechanic, pipefitter, welder, carpenter and a millwright. Whatever task he was involved in, he did it well.

In 1989, Carl began his lead-



ership role by serving in the appointed officer chairs and right through the elected positions until he became Governor in 1994-1995.

He would serve as the Membership and Blood Bank Chairman in the 7th District. Also, Carl served as Assistant Sgt-At-Arms and Sgt-At-Arms for his district, as well as Finance Officer

In 1989, Carl joined the Blue Hen Moose Legion #186 and became actively involved in the Moose Legion and the Moose Legion Committee at Harrington Lodge. He served on the Blue Hen Moose Legion Ritual Staff and progressed through the chairs to become a Past President.

The Fellowship Degree of Honor was conferred upon Carl in August of 1995. Carl became a member of the "25 Club" in February of 1995 after he signed up his 25th member. Throughout his Moose membership, he has sponsored more than 50 members into the Fraternity.

The Loyal Order of Moose wasn't the only organization that benefited from Carl's dedication to service. He was also a member of the Whiteford, MD American Legion Post for 35 years; he was a Life Member of the Greenwood, DE VFW; Past President of the Muddy Creek, PA Civic

Association and a Committee Member of the Felton Methodist Church.

Carl's years in our Fraternity were filled with activity, dedication and service leading him to be called to the House of God at Mooseheart on May 27, 2006 to received the Pilgrim Degree of Merit.

Carl would say that when he earned his Pilgrim Degree, it was not time to "step aside" and rest on his laurels, but time to "step up" and use his knowledge and experience for the betterment of the Loyal Order of Moose. So, Carl kept on going and was appointed as Moose Legion Ambassador in 2007. He was responsible for three Moose Legions in his jurisdiction and held this position for two years with outstanding leadership and direction.

Some time ago, Carl realized that he wasn't able to continue doing most of the things he had done in the past. He would say "it isn't easy letting go". He was a special man and a special Moose. Carl has left his mark on this Fraternity and represented all that is good, true and best in a Fraternity he loved so well.

We will mourn him, we will miss him, but we will **never for-get him.**

# **Youth Awareness in Action**



# A Message from our Deputy Phyllis Brainard


Hi Everyone,




