

I am happy to say that once again the Supreme Council has authorized the "0 Application Fee" for Lodges, Chapters and Moose Legions, ending on April 30, 2013. This is a \$20 savings to the prospective member. And for the sponsor, do this twice and you receive next year's dues free

So, now we have member recognition, prospective member incentive and membership reward. We have all the tools available, now it is just up to you to use these tools.

Our Mid-Year Conference is right around the corner. I certainly hope to see everyone there. Our goal is to make this time together to be informative for you, a time to see old friends and make new friends and have FUN. And then before you know it, we will be packing up for International Convention in Milwaukee, WI. This is an exciting year for everyone as we celebrate the 100<sup>th</sup> anniversary of the Mooseheart School. And, after all these years, we now have the Mooseheart School renovation project before us. I hope everyone has read about this either in the magazine or on line and have committed a personal donation to this much needed endeavor.




And now my fellow friends and members, I look forward to seeing you at Mid-Year and remember, the ball is now in your court.

## HEARD OF THE MOOSE? - THEN TELL SOMEONE!

As most of you have heard, our membership recruitment has gone flat. We are not continuing to grow our membership as we promised when we took our oath when we joined this great Fraternity. Now, we have an additional tool to grow our membership. Moose International has dropped the membership application fee as of December 17, 2012. Still, even though it is early and we were in the holiday mode, there has not been a real noticeable upwards spike in our membership recruitment during the month of December. We need to take it one step further other than investing a lot of time in new member recruitment. We need to spend more of our energies in membership retention. After a rather lengthy conference call with Moose International early in December, I believe that Moose International is going to put more effort in retention. In fact, I will be attending a Regional Managers meeting early January for helping and making recommendations for formulating a retention program for the 2013-2014 fiscal year. I truly believe that our Association could adopt a retention program that is relatively simple that a couple of our Family Centers are already using. One of the programs that I heard of being used is to have five or six members to meet at the lodge on a Saturday morning, eat breakfast together, and then call members that their dues have expired or about to expire. It is a short survey type of telephone call and each calling member only makes three or four calls which is not a big burden. The Family Center using this method has stopped the downward spiral of their membership which does prove that this program works when it is executed on a regular basis. Also another lodge had a member that normally does not attend lodge meetings but did attend a District Meeting. At this particular District Meeting membership retention was mentioned several times. This particular member obtained a listing of members whose dues were about to expire from the Administrator and called all nineteen members on the list. Fourteen of the nineteen have renewed their dues. So personal contact does work.

It is almost that time of the year again - the lodge elections. Please go to the Moose International website and download the nomination and election guide, read it, familiarize yourself with the guide, and use the guide for the lodge nominations and elections. More importantly, begin now in looking for qualified members to become officers of the lodge during the 2013-2014 fiscal year. By qualified, I am emphasizing that we

should be looking for candidates that have met the qualifications by attending the Officers Training & House Committee seminars. Those that want to be nominated for an office should obtain the training at one of our upcoming scheduled sessions. One such session is currently scheduled for Thursday.



February 14, 2013 at our Mid-Winter Conference at the Clarion Hotel in Ocean City, Maryland. Even those members whose training credentials are about to expire should attend this session to renew their credentials. Why wait until the last minute? Get it over with now and avoid the hassle in obtaining the training within the sixty day grace period after being elected and trying to meet the required obligation by attending a session traveling far from where you reside.

Our Association's Youth Awareness Program was more successful this year than in years past. As you are aware, we changed our format by having a Student Congress in each District in lieu of one central Student Congress. There were two motives for this change: less travel because of the gas prices and more students would attend if a Student Congress was available within the proximity of their locale. This year we had Student Congresses in the First, Third and Fourth (they combined), Sixth, and Seventh Districts. All had excellent guest speakers that covered quite a variety of topics that dealt with the several abuses that the four to nine year old child could encounter. Attendance was up, a 65% increase in Association Officers and parents. and a 65% increase in student participation over last year. We do believe that next fiscal year's participation will improve even more as now the District Presidents will have the experience in meeting our simple requirements. Right now, our students are working on their Kids Talk presentations until February 28, 2013.





Kyle and his wife live in Montgomery, IL with their three sons.










The little one to the left was happy to see Santa - she just knew he would come see her again!









## Mooseheart/Moosehaven - Jean Neal

#### **START THE CONVERSATION!**

Do you know of a child who needs Mooseheart? If you do – please make the services of Mooseheart known to the family at your earliest opportunity before Child Protective Services becomes involved. Perhaps you know of a family facing strife and have concerns for the safety or living conditions of their children.

No child should have to grow up "in the system". "The System" is the Department of Social Services Child Protection's foster care system. While these folks operate behind a benevolent façade, and granted - most of the employees and care givers have a genuine desire to assist children in need, make no mistake that DSS/CPS is most definitely a flagrantly tolerated bureaucratic disaster.

I do have personal knowledge of the Baltimore City's Child Protective Services organization for over 25 years. From my personal experience, the most glaring fault is the inability to determine victim from perpetrator. Their record keeping and record accuracy is deplorable. They tend to treat the clients in a punitive manner. While establishing their position of power in any given case, they exempt themselves from the law and make defamatory accusations against parents or any household member where the children reside in establishing cause for removal of the children from their home. This leaves the accused in the position in having to clear their name, but too late, the children are now 'in the system' and can not be returned to the home until the process has played out. This takes MONTHS! In addition, once the accusation is made, it becomes a documented fact in the courts. CPS is under no obligation to retract or correct anything they say or do. Some people have lost their jobs because of false accusations made by the department that is supposed to protect. Once a child is in the custody of CPS the parent has absolutely no say or rights when it comes to the child's care or placement. The worst fault is when CPS has realized a mistake was made on their part or that the cause of removal for the child is deemed unnecessary, the process still has to play out as they can not admit on record that CPS is in error in any way and the family is at the mercy of CPS the courts and is utterly powerless.

You may ask how this can be an acceptable practice? Because the courts and or municipalities have sovereign immunity and while anyone can bring suit it will be extremely costly to the plaintiff, if not impossible, to find a lawyer who would be willing or brave enough to take the case because these are all his/her co-workers.

So before any family is subjected to the trials and tribulations of DSS/CPS, take some stress out of an already stressful situation and have some say as to where your children go and who will be caring for the children. When the family feels they are fully able to provide for the child again, the child can come home because Mooseheart does not take custody of the child. If a family would like for the children to visit home on holidays or for the summer – they're more than welcome to bring the child home.

Remember, Mooseheart is not just for the children of Moose members, but for any child in crisis. Maybe a family you know is facing difficult financial problems, homelessness, domestic strife, substance abuse, death of a spouse or perhaps the children may be in the care of a family member who is no longer able to care for them. Do not hesitate to offer a solution that they may not know exists for them. Start the conversation. . "Heard of Moose?"

Each time you thought you found a solution or something buried in the archives that would be of assistance, you hit a blank brick wall. These past two months have sure been an eye-opener of how, everything can be manipulated to suit a time or purpose. For years the state has known these machines existed, for years we have been inspected and visited by undercover agents, for years as long as the signs were posted no problem. This has been a long hard road, to everyone who sent a letter or e-mail, please believe it counted. I overheard several of the lawmakers say their mailboxes were stuffed and more coming in, that was our goal.



We have formed a very strong coalition which we want to keep intact so that our non-profits stay on the same page. I would like to see the same thing transpire in Maryland, I want to work on that as soon as we can breathe again. There seems to be some light at the end of the tunnel, it may not be everything we hope for, but at least we will not be living under the threat of losing licensees, arrest, bank accounts frozen and anything else they could think of.

There are three representing the coalition for our lodges, Jim Lofland for the seventh district, Calvin Pettitt for the sixth and I. Without these two helping with all the calls, meetings, visits and input, we may not have gotten this far this fast. To the Lodge administrators - if you had not gotten your information to me so that it could be put into a presentable form and get where it need to go on time, we may not have gleaned an agreement for a senator to sponsor a bill on our behalf, some did not, others did not have it there. We are negotiating, do not have an agreement as to what will be the final Bill that will be put into law. We have another meeting with the governor's two reps this Thursday - his chief Deputy Aide Greg Patterson and the Secretary of Finance Tom Cook. Most all the representatives and senators have been more than helpful and really listened to information. Please be patient and keep it positive.

Our rally was orderly and impressive; it did get the attention we wanted. Thank everyone who came to participate.

One thing very positive has come from this, we have been able to de-bunk a ton of unfavorable, miss-information, of who we are, what we do, our goals for our seniors and children and involvement in our communities. We cannot allow that impression to ever take hold again, we need to be visible with everything we do, in other words "toot our own horns". We do not want to go back to what our lawmakers said - "We had no idea you were doing all these things" and "You are the Best Kept Secret in Delaware".

God Bless America, Those in harms way and their families, and Our great Moose Family.





dance floor and stood on it while he sang. One of the gals on the side, stood on a chair to see - the floor was that crowded.





We are very excited about our upcoming conference, and looking forward to our Official Visitor Wendy Matthew from Ontario, Canada.



## The True Story of Rudolph

A guy named Bob May, depressed and brokenhearted, stared out his drafty apartment window into the chilling December night. His 4-year-old daughter Barbara sat on his lap quietly sobbing.

Bob's wife, Evelyn, was dying of cancer. Little Barbara couldn't understand why her mommy could never come home. Barbara looked up into her dads eyes and asked, "Why isn't Mommy just like everybody else's Mommy?" Bob's jaw tightened and his eyes welled with tears. Her question brought waves of grief, but also of anger. It had

been the story of Bob's life. Life always had to be different for Bob. Small when he was a kid, Bob was often bullied by other boys. He was too little at the time to compete in sports. He was often called names he'd rather not remember. From childhood, Bob was different and never seemed to fit in.

Bob did complete college, married his loving wife and was grateful to get his job as a copywriter at Montgomery Ward during the Great Depression.

Then he was blessed with his little girl. But it was all short-lived. Evelyn's bout with cancer stripped them of all their savings and now Bob and his daughter were forced to live in a two-room apartment in the Chicago slums.

Evelyn died just days before Christmas in 1938. Bob struggled to give hope to his child, for whom he couldn't even afford to buy a Christmas gift. But if he couldn't

buy a gift, he was determined a make one - a storybook. Bob had created an animal character in his own mind and told the animal's story to little Barbara to give her comfort and hope.

Again and again Bob told the story, embellishing it more with each telling. Who was the character? What was the story all about? The story Bob May created was his own autobiography in fable form. The character he created was a misfit outcast like he was. The name of the character? A little reindeer named Rudolph, with a big shiny nose

Bob finished the book just in time to give it to his little girl on Christmas Day. But the story doesn't end there. The general manager of Montgomery Ward caught wind of the little storybook and offered Bob May a nominal fee to purchase the rights to print the book. Wards went on to print "Rudolph the Red-Nosed Reindeer" and distribute it to children visiting Santa Claus in their stores.

By 1946 Wards had printed and distributed more than six million copies of Rudolph. That same year, a major publisher wanted to purchase the rights from Wards to print an updated version of the book. In an unprecedented gesture of kindness, the CEO of Wards returned all rights back to Bob May.

The book became a best seller. Many toy and marketing deals followed and Bob May, now remarried with a growing family, became wealthy from the story he created to comfort his grieving daughter.

But the story doesn't end there either. Bob's brother-in-law, Johnny Marks, made a song adaptation to Rudolph. Though the song was turned down by such popular vocalists as Bing Crosby and Dinah Shore, it was recorded by the singing cowboy, Gene Autry.

"Rudolph the Red-Nosed Reindeer" was released in 1949 and became a phenomenal success, selling more records than any other Christmas song, with the exception of "White Christmas." The gift of love that Bob May created for his daughter so long ago kept on returning back to bless him again and again. And Bob May learned the lesson, just like his dear friend Rudolph, that being different isn't so bad. In fact, being different can be a bless-

The creator of "Rudolph, the Red-Nosed Reindeer" passed away at the age of 71 in 1976. Rudolph himself turned 72 in January 2011.

PS: A side note to this great heart warming story. Gene Autry was looking for a flip side song for another song he had already recorded. If you will remember all the great hits by artists had a throw away song on the back side of the record that no one liked or ever played. The throw away song, Rudolph, became the hit song.

Gene's wife found the Rudolph the Red Nosed Reindeer song and told Gene that this song was a must for him to record and so he listened to his wife and **now you know why it is important for**


