

### Will You Be a Piece of the Solution and Make a Difference?





We are almost halfway through the membership year and have not met 50% of our new member goals in our Lodges, Chapters and Moose Legions. Several

Lodges and Chapters are on track for exceeding their new member goals. They are on track for numerous reasons - they are The Friendliest Place in Town, they have numerous Family Activities planned for members and their families, they are active in Community Service, their Lodge Home is clean inside and attractive from the curb, they attend Association meetings and training sessions, and they are proud of being a member of the Moose Fraternity.

Nationally our expired members stand at around 20% on average. Our Association goal is to have a 10% increase in active membership this year. As I write, our Association is down 2% (LOOM and WOTM totals) of active members over last year. We can remedy this by contacting our Lodge, Chapter and Moose Legion members that are on the expired member lists. If each unit has 50% of expired members paying their dues, we could achieve a 10% increase of active members. It is achievable if these lapsed members are contacted. We **must** make personal contact and remind them that their dues have expired. Personal means making verbal contact via the phone or via an email or letter.

I expect every Lodge and Chapter to have a list posted in the Social Quarters of expired and dropped members (edit out contact information). Our active members can help by contacting a friend or family member that they see on the list and ask them to be a *Piece of the Solution* by paying their dues. Explain to our delinquent members the benefits of Moose membership. They joined because they were promised these benefits. They have not paid their dues because we have not honored these promises.

Congratulations to our newly qualified 5 Club members. Kudos to the men who have earned an **Association 2009-2010 Campaign** shirt for sponsoring 7 members, and special thanks to our 2 Top Sponsors for earning the Windbreaker for sponsoring a total a total of 15 members this year. We have 7 months remaining for the rest of you to earn these awards. Many of you are only one or two applications from earning the shirt or the jacket.

Please remember that all fraternal units are asked to donate at least \$100 to Safe Surfin' and Special Olympics. Checks are made payable to Moose Charities and earmarked for the program you are donating to. Our Association did an outstanding job support Safe Surfin' last year; let's have a repeat this year.

You will be receiving **Holiday Seals** in the mail shortly. Your donations to this project will benefit our children at Mooseheart, residents at Moosehaven and the MD-DE-DC Moose Association. Please give what you can - every donation, no matter the size, does make a difference.

ton newspaper about the Moose Riders organizing a benefit for a young man with the same disease. So she reached out to the Moose Riders and they came to help her.


"I am overwhelmed. I tried to get other organizations to help me, but they said they couldn't do it. These guys came through for me and I am feeling really good right now." Ms. Newcomer said. She had attended one of their meetings to let them determine how they could help. They quickly organized a motorcycle and golf cart show to make the funds needed to build her ramp. President Jim Boone, who has 10 years experience in the building trade, designed the ramp and obtained the necessary permits with the county.

## Government Relations Message by Association Coordinator Bessie Staab-Hickman

On top of all the other promises and controversy about this health reform issue, I have heard or seen little to be enthused about. The president is making statements and so are those in favor, those who oppose are doing

the same. Now we have the famed "six". Folks let's use our intelligence; any one can tell you anything, but let's see all this in the form of a Bill short and in language anyone can read and understand, that deals ONLY with health issue. We don't need something that will take tons of panels and lawyers a week of Sundays to wade through and have each give their version. The problem needs to be defined, what's driving up the costs? Let's start with having the insurance companies in charge of Medicare (conflict of interest?). Allowing all the torts (unreasonable law suits), paying three million dollars in a lawsuit for someone who burned their tongue on hot coffee; unnecessary packaging, I have one that is a capsule that must be put into a device and broken to inhale, I pay over and above insurance allowances. Ask any health care worker or visit any emergency room and you'll find that many are going there for service that could be dealt with in an office visit - they go there to have it paid for. The children are covered under "The Dream Act" and Chips. The social services pick up the prescriptions costs... So get that issue right off the table. We are paying for all this coverage NOW with our taxes, could this be another reason for the high costs that are draining Medicare? As for me until I find some drastic changes some real proposals, not promises, I'll agree with my cat - "spray on it and send it to the trash". We currently have issues pertaining to our Female Veterans that need to be passed, they have a unique set of health issues that have been over looked for years, and there are other health issues there as well S 252. PATIENT CARE GROUP SCAM - there is a company calling to say they are helping to administer the VA's prescription program. IT IS A SCAM - DO NOT GIVE ANY CREDIT CARD INFORMATION TO ANYONE WHO CLAIMS TO REPRESENT THE VA (VETERANS ADMINISTRATION). IT'S A SCAM

I will be happy to share information of names, e-mails, telephone numbers, and addresses - just let me know. You government relations people will need these to distribute to the members. Many chapter representatives picked up copies to take back with them from the August Conference.



# Congratulations to Mr. & Mrs. Edward Pelkey - June 19, 2009




Moosehaven has been named the "City of Contentment" for quite a long time. This rings

wishes to Ed and Mary. May they enjoy many years together in the "City of Contentment".




#### 1st Capital Fund Golf Outing Nets \$2,481 for Moosehaven Nurse Call System







# Youth Awareness Coordinators Ernie Megee and Pat Cihak


Our Association's 23rd Youth Awareness Student Congress was hosted by Elkton Moose Family Center #851 on Friday and Saturday, October 2, and 3, 2009. This program was a huge success this year as we had 30 students registered, 23 students attending the program and 30 adults in attendance - totaling 53, which is 70% more than last year.

Our Student Congress began early Friday evening with student room registration at the Comfort Inn & Suites in North East, Maryland. After everyone settled in, we traveled to the Elkton Moose Family Center for a get-acquainted party. At the Family Center, students were welcomed by members and officers of the Family Center. Pizza, fries, chips and drinks were prepared by the Family Center members and served. Also, for entertainment, there was a DJ who played current tunes for the students. The DJ was very good in working the crowd as the majority of the time students and adults were dancing on the floor. One of the things that impressed us was that when a student requested a song and it was not in the DJ's stock, he immediately downloaded the song off the internet and played the request. Around 9:30 PM the students returned to the hotel/motel to swim and work out in the gym area.

We returned to the Family Center early Saturday morning for a big breakfast. The members had prepared scrambled eggs, bacon, sausage, etc. At 8:00 AM registration began with the main program beginning at 9:00 AM. We had two guest speakers - Detective First Class Angel Valle of the Cecil County Sheriff's Office and Marie Allen from "Heroin Alert" in New Castle County. The guest speakers' presentations, videos, and slides were sometimes graphic, but were awesome. Detective Valle's presentation was about the dangers of the internet and how people prey upon young children playing on their emotions to become their "best friend". He also wanted the students to warn 4 to 9 year old children about the ways they could be lured away and abused. During his presentation, he also mentioned the problems of children today by taking pictures of themselves and how that one picture can get into the hands of many through the use of the internet. He mentioned how this could haunt them when the person applies for a position

in the future.

Marie Allen spoke about the perils of heroin and how it caused the death of her





she came out to her mother in the waiting room, she was white as a ghost - when the nurse put the needle in her arm, it triggered something - it made her think about using heroin bringing back all her feelings and cravings for the drug making her feel like she was going through withdrawal. She returned to

work and completed her shift, but did not report back to the Crest Program. A few days later, Marie Allen received the phone call from the Coroner's Office in Philadelphia advising that Erin had overdosed on heroin

Both guest speakers were awesome and very informative. Marie Allen's presentation brought a lot of tears among students and adults. It was a very touching and graphic presentation. At the end, she advised that she authored a book, based on her experiences and those of Erin. Our Association purchased a copy for each student attending.

This Student Congress was the best that we have had in many years. We feel that the success of this Congress was the result of the untiring efforts of the Elkton Moose Family Center and their administrator, John Kitchen. They were very friendly, supportive, and accommodating. From what the students told us, the day and a half that they spent at the Congress was very beneficial and not time wasted. Pat and I really appreciate those who took the time to bring the students and to attend this very worthwhile and important program.







## Remember Our Veterans - Nov. 11

# 1. How many steps does the guard take during his walk across the tomb of the Unknowns and why?

21 steps. It alludes to the twenty-one gun salute, which is the highest honor given any military or foreign dignitary.

# 2. How long does he hesitate after his about face to begin his return walk and why?

21 seconds for the same reason as answer number 1.

#### 3. Why are his gloves wet?

His gloves are moistened to prevent his losing his grip on the rifle.

#### 4. Does he carry his rifle on the same shoulder all the time? And if not, why not?

He carries the rifle on the shoulder away from the tomb. After his march across the path, he executes an about face and moves the rifle to the outside shoulder.

#### 5. How often are the guards changed?

Guards are changed every thirty minutes, twenty-four hours a day, 365 days a year.

#### 6. What are the physical traits of the guard limited to?

For a person to apply for guard duty at the tomb, he must be between 5' 10' and 6' 2' tall and his waist size cannot exceed 30. Other requirements of the Guard:

They must commit 2 years of life to guard the tomb, live in a barracks under the tomb, and cannot drink any alcohol on or off duty for the rest of their lives. They cannot swear

in public for the rest of their lives and cannot disgrace the uniform {fighting} or the tomb in any way. After two years, the guard is given a wreath pin that is worn on their lapel signifying they served as guard of the tomb. There are only 400 presently worn. The guard must obey these rules for the rest of their lives or give up the wreath pin. The shoes are specially made with very thick soles to keep the heat and cold from their feet. There are metal heel plates that extend to the top of the shoe in order to make the loud click as they come to a halt. There are no wrinkles, folds or lint on the uniform. Guards dress for duty in front of a full-length mirror. The first six months of duty a guard cannot talk to anyone, nor watch TV. All off duty time is spent studying the 175 notable people laid to rest in Arlington National Cemetery ... A guard must memorize who they are and where they are interred. Among the notables are: President Taft, Joe E. Lewis {the boxer} and Medal of Honor winner Audie Murphy, {the most decorated soldier of WWII} of Hollywood fame. Every guard spends five hours a day getting his uniforms ready for guard duty.

#### ETERNAL REST GRANT THEM O LORD, AND LET PERPETUAL LIGHT SHINE UPON THEM.

In 2003 as Hurricane Isabelle was approaching Washington, DC our US Senate/House took 2 days off with anticipation of the storm. On the ABC evening news, it was reported that because of the dangers from the hurricane, the military members assigned the duty of guarding the Tomb of the Unknown Soldier were given permission to suspend the assignment. They respectfully declined the offer, 'No way, Sir!' Soaked to the skin, marching in the pelting rain of a tropical storm, they said that guarding the Tomb was not just an assignment, it was the highest honor that can be afforded to a serviceperson. The tomb has been patrolled continuously, 24/7, since 1930.
